**RESTORATION OF PROJECT**  
 Maintenance of backfilling paved and unpaved streets and sidewalk excavations.

When backfilling the excavation of any permit location, the following steps are to be used: All fill material must be tamped and compacted in lifts of not more than six inches at one time. Persons to whom the permit is granted must be responsible to maintain a smooth and level surface of the excavation site for a period of (1) one year after the completed permit date. All sidewalk blocks and asphalt must be replaced with new materials as designed. (Concrete must be a minimum of a 3500 # mix, Sidewalk blocks must be a minimum of 4 ½" thick, Sidewalk blocks crossing a driveway must be a minimum of 6 ½" thick.)

**PROJECT MUST BE COMPLETED WITHIN 60 DAYS OF DATE OF PERMIT**

All work under any project shall be supervised by the Superintendent of Public Works or his duly authorized representative. Upon completion of the project, the Superintendent of Public Works or his duly authorized representative shall inspect the premises and give his approval of the restoration. If necessary, a permittee may be required to return to the project area if additional restoration work is necessary to put the project area into the same condition it was in prior to the project.
